# Background In accordance with the Indonesian regulation (Govt. Regulation no. 41 / 2006), all foreign researchers must obtain an official permit from the Indonesian authority in advanced. The Foreign Research Permit (FRP) is published by

- The Foreign Research Permit (FRP) is published by Ministry of Research, Technology and Higher Education (RistekDikti).
- Currently BMKG role as Indonesian Counterparts for Banda Sea Cruise, Terramaris and R/V Investigator.

## Foreign Research Permit (FRP)

- Indonesian ministry of research and technology is providing online system for FRP application (http://frp.kemenristek.go.id)
- All procedures and communication have to be done online, including the application form, uploading all necessary documents and the later reports as well.

### Procedure (Pre-Arrival)


- 1. Online Registration (Fulfill the application form) → UserID & Password
- 2. Upload the required document<sup>\*)</sup>
- 3. TKPIPA Virtual Meeting  $\rightarrow$  Pre Approval

TKPIPA = Coordinating Team / Commitee for FRP Approval.

Consist of multi government institutions

4. Pre Approval → Visa C315 Publication (Indonesian Embassy / Consulate general / Representative Abroad)



- All the equipment will be brought to Indonesia (luggage or hand carry) should be listed in the IA including the price.
- If the total price reach **500 USD**. The Immigration office will give **the import duties liberation letter** to free the custom cost.

#### Research Proposal Should Contains at Least:

- 1. Title
- 2. Research Objectives which should give mutual benefits for both counterparts.
- **3. Methodology** (Explain how the research will be conducted and **All the equipment details**: type, brand, function and price should be mentioned clearly, and the international airport/port where the equipment will be imported to).
- 4. Locations (Name of the places, buildings or cities where the research will be conducted).
- 5. The name of all researcher involved (Position in the team, Date of Arrival to and Return from Indonesia)
- 6. Duration (Research time table)

- 1. Objectives
- 2. Scope of Activities
- 3. Implementation
- 4. Financial Arrangement
- 5. Civil Liability
- 6. Equipment
- 7. Publications
- 8. Limitation Of The Personnels
- 9. Settlement Of Dispute
- 10. Entry into Force, Durations and Termination





#### General requirements

- **1. A formal letter of request** addressed to The Ministry of Research, Technology and Higher Education.
- 2. Copy of **Research Proposal**.

**BMKG** 

- 3. Copy of **Abstract** of the research proposal.
- 4. Scanned copy of Applicant's passport.
- 5. Copy of the **applicant's curriculum vitae** (CV) including a list of publications.
- 6. Copy of **local counterpart's Curriculum Vitae** including a list of publications
- 7. Copy of applicant's recent close up photograph

#### General requirements (Continue) **BMKG** 8. Signed MOU, IA and Letter Of Agreement with Indonesian Counterparts<sup>\*)</sup> 9. Letters of recommendation 10. A letter of acceptance from Indonesian Counterparts. 11. A letter of guaranteeing sufficient fund 12. Health certificate

13. A list of research equipments that will be brought or imported to Indonesia
